**ORDER SUSTAINING FIFTH OMNIBUS (SUBSTANTIVE)  
OBJECTION OF THE DEBTORS TO CLAIMS PURSUANT  
TO 11 U.S.C. § 502(B), FED. R. BANKR. P. 3003 AND 3007 AND LOCAL RULE 3007-1**

UPON CONSIDERATION OF the Fifth Omnibus (Substantive) Objection of the Debtors to Claims Pursuant To 11 U.S.C. § 502(b), Fed. R. Bankr. P. 3003 And 3007 And Local Rule 3007-1 (the “Fifth Omnibus Objection”) filed by above-captioned debtors and debtors-in-possession (the “Debtors”); the Court having reviewed the Fifth Omnibus Objection and finding that (a) the Court has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334; (b) this is a core proceeding pursuant to 28 U.S.C. § 157(b)(2); (c) notice to the holders of the claims set forth on Exhibit A to this Order (collectively, the “Reclassified Claims”) of the filing of, response deadline of, and hearing date regarding the Fifth Omnibus Objection was sufficient under the circumstances; (d) the Court has reviewed the Fifth Omnibus Objection and the responses filed to the Fifth Omnibus Objection; (e) the Debtors has sought to adjourn the hearing with respect to the claims set forth on Exhibit B to this Order (the “Adjourned Claims”) to the omnibus hearing scheduled for December 21, 2010 at 3:30 p.m.; (f) a hearing has been held on the Fifth Omnibus Objection with respect to the Reclassified Claims; (g) no responses to the

Fifth Omnibus Objection have been filed and not withdrawn or overruled with respect to any of the Affected Claims; and (h) the Court having determined that the Reclassified Claims should be reclassified to the extent set forth herein; IT IS HEREBY ORDERED AS FOLLOWS:

1. The Fifth Omnibus Objection is SUSTAINED, with respect to each of the Reclassified Claims, <sup>kp</sup> **subject to Debtors' REPRESENTATIONS MADE ON THE RECORD.** All capitalized terms not otherwise defined herein shall have the respective meanings set forth in the Fifth Omnibus Objection.

2. All objections to the Fifth Omnibus Objection with respect to the Reclassified Claims, to the extent not withdrawn, are hereby OVERRULED.

3. Each of the Reclassified Claims identified in Exhibit A attached hereto is reclassified as being asserted in with the status set forth in the columns under the title "Modified Classification Status" in Exhibit A hereto. The Reclassified Claims are hereby DISALLOWED except to the extent set forth in the columns under the title "Modified Classification Status" in Exhibit A hereto.

4. The hearing on the Fifth Omnibus Objection with respect to the Adjourned Claims identified on Exhibit B hereto is hereby adjourned the omnibus hearing scheduled for December 21, 2010 at 3:30 p.m..

5. Nothing herein shall prejudice the right of any party to object to any of the claims asserted in these chapter 11 cases, on any basis.

6. Each Reclassification Claim and the objection to such claim, as addressed in the Fifth Omnibus Objection and as set forth on Exhibit A hereto, constitutes a separate contested matter as contemplated by Rule 9014 of the Bankruptcy Rules and Local Rule 3007-1. This Order shall be deemed a separate Order with respect to each Reclassified Claim. Any stay of this Order pending appeal by any claimant whose Reclassified Claim are subject to this Order shall only apply to the contested matter which involves such claimant and shall not act to stay the

applicability and/or finality of this Order with respect to the other contested matters listed in the Fifth Omnibus Objection or this Order.

7. This Court shall retain jurisdiction with respect to all matter arising from or related to the implementation of this Order.
