
AFFIDAVIT OF SERVICE



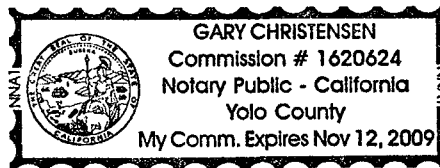
