1. On March 8, 2010, the Court entered the *Amended Order Establishing Procedures for Interim Compensation and Reimbursement of Expenses of Professionals* (the “Interim Compensation Order”) [Docket No. 147].

2. In accordance with the Interim Compensation Order, on June 28, 2010, Jager Smith P.C. (“Jager Smith”) filed its *Fourth Monthly Application for Compensation for Services Rendered and Reimbursement of Expenses as Counsel for the Committee for the Period From May 1, 2010 to and Including May 31, 2010* [Docket No. 365] (the “Application”) with the United States Bankruptcy Court for the District of Delaware.

Pursuant to the Notice of Application, objections were to be filed and served no later than July 13, 2010 at 4:00 p.m. Jager Smith did not grant



any extensions of such objection deadline and has no knowledge of any other party granting any such extensions.
